Dengan hormat,

Merujuk kepada Keputusan Ketua Badan Pengawas Pasar Modal No. KEP-86/PM/1996 Peraturan No X.K.1, mengenai Keterbukaan Informasi Yang Harus Segera Diumumkan kepada Publik serta Ketentuan PT Bursa Efek Indonesia No.IV.3 Peraturan No. I-E, mengenai Kewajiban Penyampaian Informasi, berikut kami sampaikan keterbukaan informasi mengenai musibah kebakaran di salah satu fasilitas produksi hilir Perseroan yang berlokasi di Jalan Balmerah Baru III, Belawan II, Medan.

Kebakaran terjadi pada hari Senin, tanggal 13 Juli 2015, sekitar pukul 18.50 WIB.

Fasilitas yang terkena dampak kebakaran tersebut adalah fasilitas pemrosesan margarin dan *shortening*, fasilitas *filling* dan pengemasan, serta sebagian gudang barang jadi yang berdampingan dengan fasilitas pemrosesan tersebut.

Fasilitas produksi lainnya seperti rafinasi, fraksinasi, pemrosesan *Cocoa Butter Substitute*, fasilitas pengolahan inti sawit, serta gudang barang jadi lainnya tidak terbakar dan dapat berfungsi secara permal

Tidak terdapat korban jiwa maupun korban yang terluka dalam peristiwa ini. Saat ini, penyebab pasti dari kebakaran tersebut sedang dalam proses investigasi dari pihak berwajib yang terkait. Manajemen Perseroan sedang dalam proses penghitungan estimasi nilai kerugian yang timbul dari peristiwa ini. Aset yang terbakar tersebut dilindungi oleh asuransi kebakaran.

Berdasarkan data tahun 2014, kontribusi pendapatan dari lini produksi yang terbakar ini tidak material; kuantitas penjualan dari lini produksi yang terbakar kurang dari 1% dari jumlah kuantitas penjualan Perseroan. Perseroan terus memproduksi margarin dan *shortening* serta minyak goreng bermerek dari pabrik Perseroan yang berlokasi di Marunda dan Surabaya, sehingga ketersediaan produk tetap terjamin.

Dear Sir and Madam,

We refer to the Decree of the Head of the Capital Market Supervisory Board No. KEP-86/PM/1996 Rule No X.K.1, regarding Disclosure of Information That Must be Announced to the Public as well as Indonesia Stock Exchange Regulation No.IV.3 Rule No.I-E, regarding Obligation of Information Submission, we hereby submit disclosure of information about the fire accident in one of the Company's downstream production facilities located at Jalan Balmerah Baru III, Belawan II, Medan.

The fire accident happened on Monday, 13 July 2015 at approximately 18.50 Western Indonesian Time.

The damaged facilities consist of a margarine and shortening processing facility, filling and packing facilities, as well as part of a finished good warehouse located next to the affected facilities.

Other production facilities such as refinery, fractionation, Cocoa Butter Substitute processing, kernel crushing plant, and another finished good warehouse were not damaged and can be operated as per normal.

There were no casulties nor injuries caused by this accident. The exact cause of the fire is currently under investigation by the relevant Indonesian authorities. Our management is likewise in the process of estimating the total loss incurred. The impacted assets are covered by fire insurance

Based on 2014 data, revenue contribution from the damaged production lines is not material; sales volume from the damaged production lines represents less than 1% of the Company's total sales volume. The Company continues to produce margarine, shortening and branded cooking oil products from its other plants located in Marunda and Surabaya, thereby ensuring the availability of these products.
