Notification on RSPO Recertification-1 of Indrasakti POM – PT Meganusa Intisawit a subsidiary of Golden Agri Resources Ltd. (RSPO Membership Number 1-0096-11-000-00)

Dear Stakeholders,

Golden Agri Resources Ltd. has applied to Mutuagung Lestari for RSPO Recertification to Indrasakti POM – PT Meganusa Intisawit (RSPO Membership Number 1-0096-11-000-00) and its supply based, located in in Sub District of Rakit Kulim, District of Indragiri Hulu, Riau Province Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

Golden Agri Resources Ltd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. Golden Agri Resources Ltd. has been registered since March 31, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct Recertification of Indrasakti POM – PT Meganusa Intisawit which has 1 (one) mill 1 (one) estate, and 3 (three) smallholders on 25th to 29th June, 2018.
