Notification of RSPO Re-Certification Tanah Laut POM PT SMART subsidiary of Golden Agri Resources Ltd (RSPO Membership 1-0096-11-000-00, 30 January 2005)

Dear Stakeholders,

GAR has applied to Mutuagung Lestari and will conduct Re-Certification at PT SMART – Tanah Laut POM and its supply based, located at Bukit Mulia Village, Kintap Sub District, Tanah Laut District, Kalimantan Selatan Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

Tanah Laut POM has successfully been registered in the PalmTrace IT platform with member RSPO_PO1000001152. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to maintain RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill and 2 (two) estates on **11 to 15 July 2022**.

GAR is the world second largest palm oil with total planted 433.200 hectares as of 30 June 2010 in Indonesia. It has integrated operations focuses on the production of palm-based edible oil and fat product. Founded in 1996, GAR is listed on the Singapore Exchange since 1999 with the market capitalization of US\$4.59 as on 30 June 2010. GAR has several subsidiaries, including PT SMART Tbk (SMART), which listed on the Indonesia Stock Exchange in 1992. GAR is focused on sustainable palm oil production. Primarily, cultivating and harvesting of oil palm trees; processing of fresh bunch into crude palm oil (CPO) and palm kernel. PT SMART – Tanah Laut POM is located in Kintap Sub District, Tanah Laut District, Kalimantan Selatan Province,

Indonesia with certification unit consist of 1 (one) palm oil mill, 2 (two) oil palm estates under company management, RSPO certified since 2012. Currently PT SMART – Tanah Laut POM does not have an NPP and a RaCP process

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001:2015) and Environmental Management System certification body (ISO 14001:2015). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body, Certification Body of Indonesian Sustainable Palm Oil (ISPO), Since March 2014, MUTU has been accredited by ASI (Accreditation Services International) as a RSPO certification body.
